

Present: Mike Prusilla (SMC), Rob Flood (North Shore Reclamation District/Gages Lake), Nick Huber (LCFPD), Gerry Urbanozo (LCHD), Jeff Laramy (SMC), Beth Adler (DRWW Technical Committee), Alana Bartolai (LCHD), Tom Morthorst (Third Lake)

- 1. Call the meeting to order: Mike Adam called the meeting to order
- 2. Approve agenda for the meeting. Mike Prusilla made a motion to approve the agenda , Rob Flood seconded the motion. The motion passed unanimously.
- 3. Motion to approve previous meeting minutes. Alana Bartolai made the motion to approve the minutes, Rob Flood seconded. The motion passed unanimously.
- 4. Public Comment:
 - a. In the future it would be beneficial to have a public meeting where all lake associations are invited and Lakes Committee presents updated information (data) and receive input.
- 5. Review of ILMA POD from HAB Aquatic
 - a. Good turnout at the ILMA POD on 1/25/17 at the Wauconda Moose Lodge. Interesting topic on alum treatments for water quality with Lake Barrington example
 - b. Questions still remain: Shallow lake's plant response?, pH and chemical reactions of alum treatments? Can associations afford the cost?
- 6. DRWW Impaired Waters and Monitoring Sites Map (Presented by Jeff Laramy SMC)
 - a. SMC created an impairment and monitoring site map that is now available on the website.
 - b. Map shows 305b and 303d reaches and lakes
 - i. Question: Does 305b list impairment? Only see causes on the list
 - c. Flow data also on map USGS flow monitoring sites links to USGS website
 - d. This map can be adjusted throughout time for instance if we want a layer that shows lakes with phosphorus impairments, different layers with different data sets streams, lakes, fish/macros, lake contacts, etc.
- 7. DRWW Draft Workplan (Presented by Beth Adler)
 - a. Make sure Lakes Committee has some input into workplan. Workplan presented at Feb 16th in draft form at annual meeting any comments need to send to Beth soon
 - b. 4 strategies in the Watershed Plan mostly developed during executive board meeting
 - i. Monitoring/assessment
 - ii. Regulatory Relationships/Permits
 - iii. WQ Improvement projects Planning & Implementation
 - 1. Need to make sure we include lake projects
 - iv. Leadership & Engagement

- c. After Workplan is finalized, next step is developing action items. Workplan is a 5 year timeframe.
- 8. What is objective for Lakes Committee?
 - a. Most updated data for lakes in DRWW
 - b. Making recommendations for projects identified in the watershed or in the lake itself
 - c. Providing list of projects to watershed plan.
 - d. How do we prioritize projects and feasibility?

 - b. This type of analysis may help us prioritize projects
- 13. Data Needs/Gaps
 - a. Impairments, TMDLs, stream data
- 14. Recommendations to Executive Board
 - a. Give list of lakes with impairments, what the impairments are for each lake, and list of projects. Projects can be summarized from LCHD reports and input from associations—this needs to be in the watershed plan by SEPTEMBER. If your projects are not in the watershed plan it will not be updated for another 10 years so your chance of funding is limited.
 - b. General lake management issues that affect lakes more broadly:
 - i. Education plans
 - ii. Chloride Management Plans
 - iii. Sediment Erosion
 - iv. Lake Management Structure
 - v. Grants
 - c. Any monitoring money available for lake? Fine tuning monitoring (inlets, in-lake nutrients/sediment cores). Many lakes are in the MS4 townships. Maybe come up with a list of lakes that would be good.
- 15. Next meeting April 27th, 2017
 - a. Might need more meetings
 - b. Some meetings could be "working meetings"
 - c. Localized Lake County Meeting Lake association, is there a need for lake associations to have a format to connect with each other?

Other issues:

- IL EPA requirements for impairment list is outdated and doesn't really reflect true water quality. Might be worthwhile to meet with IL EPA and others involve and discuss changes in how these impairements are listed (i.e. beach e.coli data)
- Lake homeowners/associations always have issue finding funding. More information about potential grant opportunities or how the DRWW process may increase their likelihood to fund projects on their lake would be a good educational effort.
- Information for lake owners to understand construction & erosion -who to call if they don't see silt fences, etc.
- Some committee members would like to seemore representatives from every impaired water body.



- 1. Call the meeting to order: Mike Adam called the meeting to order.
- 2. Approve agenda for the meeting. Rob Flood made a motion to approve the agenda, Alana Bartolai seconded the motion. The motion passed unanimously.
- 3. Motion to approve previous meeting minutes. Rob Flood made the motion to approve the minutes, Alana Bartolai seconded. The motion passed unanimously.
- 4. Public Comment:
 - a. No public comment
- 5. Des Plaines Lake Public Meetings
 - a. Since last lakes committee meeting, the Lakes Committee presented at the DRWW annual meeting and an additional night meeting
 - i. Evening meeting was not well attended, but the panel discussion at the DRWW went really well.
 - ii. Press write-up was good.
 - iii. Future panel discussion with different lakes. Lakes Committee could co-chair an ILMA POD or similar type of event/discussion.
 - b. Future Meetings/Presentations
 - i. Rob Flood suggested a meeting on highlight mechanically removing weeds as an alternative to chemical herbicides. This could be a demonstration at a lake and in coordination with ILMA PODs. Rob offered Wildwood Park District as a host for the meeting. POD recommended for early June.
 - ii. Steve Mccomis from Minnesota has a review of different removals methods, can review his work for meeting.
- 6. ILMA Lakes Conference and Workshop
 - a. Held March 31-April 1st
 - b. Lake Management Planning Workshop well attended 45 attendees
 - c. Lake management plan should be in all recommendations for lakes.
- 7. Old Business
 - a. Lake Questionnaire
 - i. Will send out on SurveyMonkey group.
 - b. Lake Recommendations/Priorities for Watershed Plan
- 8. Other Business:
 - a. Zebra mussel monitoring
 - i. Mike & Jim had a meeting with College of Lake County to discuss potential for a small project to monitor Zebra Mussels on Third Lake.

- ii. Three buoys in Third and three buoys in Druce have been proposed to Village of Third Lake in the no-wake areas (~150 ft of shoreline)
- iii. Goal is to get College of Lake County to incorporate this.
- b. Lake Load calculations
 - i. Many models are available and it's important to discuss with DRWW contractors if they will be incorporating any lake models in their analysis.
 - 1. WiLMs
 - 2. Canfield-Bachman (shallow lakes)
 - ii. Chris Yoder/Salt Creek Goal goal is it to improve biodiversity.
 - iii. Future conversation is needed with DRWW & consultant to discuss their role in modeling or if potential for staff at SMC or LCHD to analyze.
- 9. Other Items discussed
 - Beth Adler brought up that a lot of MS4s are <25,000 and don't see the interest in joining DRWW, but they will grow. We need to provide insight for watershed plan regarding areas that should be preserved and where development has not occurred yet.
 - b. Watershed plans should be incorporated in the comprehensive building & development plans. DRWW can play a role in educating the importance of this.
 - c. DRWW could have workshops to discuss importance of incorporating these watershed plans into development plans and how to be pro-active rather than reactive.
 - d. Chloride
 - i. Lakes Committee could tackle chloride as a project.
 - ii. Create GIS maps that show roads close to waterways where chlorides can be reduced.
 - iii. Can include in our list of recommendation
 - e. Large-scale green infrastructure: how do you manage green infrastructure.
 - i. Could be another workshop/presentation.





Q2 What are the major uses of your lake? Check all that apply.



Q3 Are there any restrictions on motors on your lake?



Q4 What is the current lake management structure?



Q5 What are your primary management issues? Check all that apply





Q6 What are your most significant challenges? Check all that apply.




Q8 How do you educate your lake residents?

Q10 What types of issues would you like assistance with? Check all that apply.



Q11 How does your group fund Lake Management activities?



Q12 Are you familiar with any of the following programs? Check all that apply.




