### 1. Call the Meeting to Order

### 8. Old Business

• Continuous Monitoring: The North Shore Water Reclamation District (NSWRD) has installed continuous monitoring probes in the Des Plaines River Mainstem at Russel Rd., Highway 120, and Half Day Rd. These are temporary installments which will be replaced with permanent structures to allow access from the bridge deck during high flow events. The stuctures will be similar to structures used by the Metropolitan Water Reclamation District of Greater Chicago. The State of Illinois plans on reconstructing the Highway 120 bridge in 2022. The monitoring probe may have to be moved out of the construction area if this occurs. Lake County has requested a \$1,500 application fee and \$5,000 bond to use the bridge at Russel Rd. for monitoring. Al Giertych will work with Joe Robinson to resolve this issue.
