 - a. Monitoring Updates
 - NSWRD Updates sondes back in service, will be taken out next week & data extracted, will
 find out if the one in question is still having issues. One comment on data, NSWRD still
 owes invoice to DRWW, will be done next month
 - ii. LCHD Updates-Bartolai finished July sampling yesterday. 6 dry sites, better than last year. Observed MBI when they came out and did sampling.
 - iii. MBI correspondence/update (by DRWW) Waters: briefed group on correspondence with MBI. Issues with projects in OH, will do additional sampling in DRWW area, no budget impact, rental sonde budget will be used to perform additional monitoring. Prusila Issue with access at WRI Riffle, committee to address at a later meeting.

- a. Geosyntec NARP Update hydraulic model calibration: two pretty good calibrations for main stem reaches (NSE 0.91 and 0.87). Water quality model (QUAL2K, plus SWAT for TSS): inputs are upstream boundary, tributaries, WWTPs. Calibration results (temp & total P): looking good for Temp and Phosphorus. Chlorophyll A issue: high values end of October, do not need to calibrate as it is a result of a sensor issue. Next steps: calibrate chlorophyll-a, benthic algae, and finalize dissolved oxygen, then apply same parameters to Mill Creek segment of model.
